# **RENTAL TERMS:**

- 1. The terms of this Car Rental Agreement run from February, 7th until February 12th, 2022.
- 2. A driver is provided from 6am to 12pm each day for 6 (six) days.
- 3. The above vehicle will be provided with a full tank of fuel by the Owner.
- 4. The Owner is responsible to refuel the vehicle during the rental period.
- 5. The exchange rate upon which the rental fees are based is that of the day in which the contract
- 6. The daily cost of the rental service is **Ghc 600**.
- 7. The payment of the service will be in cash at the expiration of the present agreement after submission of the relevant invoice.
- 8. The Owner must provide the Renter with proof of insurance that will cover damage to the rented vehicle as well as personal injury to the driver and passengers at the time this Car Rental Agreement is signed and during the whole rental period.

- 9. The Owner confirms that the driver will abide by all stipulated Ghanaian regulations concerning the use and operation of the rented vehicle.
- 10. The Owner agrees to indemnify and release the Renter for any damages, injuries, property loss, or death caused while the driver operates this vehicle.
- 11. The Owner is responsible for any damages that may incur during the rental period.
- 12. The Owner attests that the vehicle is in good working order and has no operational faults.
- 13. The Renter has inspected the vehicle before the commencement of the rental duration, and he confirms that the vehicle is in proper operational condition. This inspection cannot be considered as a substitution of a technical inspection by a competent and officially recognised body.
- 14. In the event of any dispute over this agreement, this Car Rental Agreement will be interpreted by the laws of Ghana, and any lawsuit or arbitration must be brought in the corresponding region of Greater Accra.
- 15. The Renter is entitled to terminate this contract by giving one (1) day notice. In the event of such termination, the Owner shall be entitled to receive the payment corresponding to the actual number of days of rental.

This Car Rental Agreement constitutes the entire agreement between the Parties with respect to this rental arrangement. No modification to this agreement can be made unless in writing signed by both Parties.
